Sub: Grant of conditional permission to the **Sufia Unani Medical College, Bara Chakia**, **East Champaran**, **Bihar** with **60** seats in BUMS (UG) course under Section 13A of the IMCC Act, 1970 for the academic session 2017-18 – reg.

Sir/Madam.

I am directed to refer to this Ministry's order no. R-12012/01/2011-EP (IM-1) dated 02.12.2016 related to admission matter for the year 2016-17 intimating certain shortcomings for rectification for consideration of the case for the academic session 2017-18.

- 2. The CCIM had carried out an inspection of the institution on 17-18.04.2017 to assess the available facilities of teaching and practical training as well as to verify the compliance submitted by the college and forwarded its recommendations and report to the Ministry. A copy of the assessment report of the CCIM is enclosed.
- 3. The recommendations and visitation report of the CCIM have been carefully examined in terms regulation 3 and 10 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Unani Colleges and attached Hospitals) Regulations, 2016", provisions under the IMCC Act, 1970, relevant regulations made thereunder and as per approval of the Hon'ble MoS (IC) for the UG/PG course(s) for grant of conditional permission for the academic session 2017-18 vide Ministry's letter No.R.11011/03/2017-EP (IM-1) dated 12.06.2017, it is found that the College is fulfilling the notified and approved criteria for conditional permission.
- 4. It has, therefore, been decided by the Central Government to *grant conditional permission* to the *Sufia Unani Medical College*, *Bara Chakia*, *East Champaran*, *Bihar* to conduct BUMS (UG) course with 60 seats for the academic session 2017-18 under section 13A of the IMCC Act, 1970, subject to the condition that the college shall fulfill the following requirements by 31<sup>st</sup> December, 2017 which will be verified for granting permission from the academic session 2018-19 onwards:
  - (i) all the requirements of the Minimum Standard Requirements of infrastructure and teaching & training facilities as specified in Regulation 3 and 10 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Unani Colleges and attached Hospitals) Regulations, 2016;

- (ii) all the requirements under the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Unani); and
- (iii) all the requirements under the provisions of the IMCC Act, 1970 and relevant Regulations made thereunder should be fulfilled *in toto*.
- 5. The fulfillment of the deficiencies pointed out in the Assessment Report of CCIM (if any) and conditions given above may be made within the time period specified and compliance report should be submitted to the Ministry of AYUSH endorsing a copy to the CCIM also. The CCIM will verify that the conditions have been fulfilled by means of an inspection and submit a report in this matter to the Ministry of AYUSH for considering the permission from the academic session 2018-19.
- 6. This issues with the approval of competent authority.
